



Jury Trial Process – Important Citizen Service





Office Priorities

VIOLENT CRIME:

- Number of Murder Cases Open in the 17th Judicial District: **52**
 - 2017-Current: Murder 1 and Murder 2 (Numbers Pulled on 5/25/2023)
- Recent Cases:
 - Defendant Sentenced to Prison for Fatally Shooting Man 13 Times in Northglenn
 - Guilty Plea to 2nd Degree Murder
 - 40 Years DOC
 - Drug Dispute: Victim Owed Defendant Money
 - Victim's BIL, SIL, and Child Were in Home
 - Defendant Convicted of First-Degree Murder; Sentenced to Life in Prison for Beating, Fatally Shooting Westminster Man
 - Convicted of First-Degree Murder by Adams Co. Jury
 - Sentenced to Life in Prison W/O Parole
 - Victim and Defendant Involved in Ongoing Dispute
 - Defendant Shot Victim in Parking Lot of his Apartment Complex
 - Defendant Convicted of Murder for Shooting Man in Head, Dumping Body in Field
 - Convicted of Second-Degree Murder by Adams Co. Jury
 - Sentencing in October
 - 20-Year-Old Defendant Shot Victim in Head While Driving His Truck in Westminster During a Drug Deal; Dumped Body in a Field in Westminster
 - Defendant Tried to Use Self-Defense



Office Priorities

DOMESTIC VIOLENCE:


- Created a Special Victims Unit to handle complicated and sensitive DV cases
- Worked to form the 17th's first ever Domestic Violence High-Risk Team to better support survivors of DV

FENTANYL:

- Helped to pass a law at the Capitol during the 2022 Colorado Legislative Session that will strengthen our ability to police and prosecute fentanyl cases
- 17th DA's Office taking deeper approach to combating fentanyl through prosecution




Office Priorities

MOTOR VEHICLE THEFT:

- Convened Local Law Enforcement Working Group
- Liaisons Assigned to Metro Auto Theft Task Force
- Flag Auto Theft Cases
- Fight for Stiffer Sentences





MENTAL HEALTH:

- Created Mental Health Hotline for Kids
- Helped Pass Legislation to Improve Colorado's Mental Health System for Adults, Youth, and Those Who Work in Law Enforcement

What Does the District Attorney Do?

Administrative:

- Run an office of 230 employees
 - Hire new employees
 - Make decisions on salary, promotions, performance reviews, etc.
 - Handle personnel related matters

Legal:

- Oversee 30,000+ criminal cases
- Personally file all homicide cases
- Make legal decision on appeals, filings, and major case resolutions
- Make legal decisions on all officer-involved shooting cases
- Prosecute a limited number of cases
 personally
- Go to homicide scenes and officer-involved shooting scenes



What Does the District Attorney Do?

Community:

- Host In-Person and Virtual Town Halls
- Collaborate with the Adams County Commissioners and all municipal city councils in my jurisdiction on issues from housing to crime reduction
- Speak to various community groups and city councils about criminal justice topics that impact their lives
- Partnership with Home Depot to address retail crime across 17th Judicial District – national model
- Represent the office at community events, fairs, etc.
- Quist Middle School Art Collaboration/Lemonade Stand Project



Political and Policy:

- Work with the Governor and State Legislators on criminal justice issues and legislation. For example:
 - Mental Health HB21-1258 Free Mental health, HB21-1068 - three free mental health visits for youth, SB22-188 Mental Health/Peer Support programs for DAs and PDs
 - HB22-1326 Fentanyl Accountability & Prevention Act
 - SB23-097 Motor Vehicle Theft & Unauthorized Use
 - Firearm Safety Bills regarding Safe Storage, Raise Age of Purchase, 3-day Waiting Period, and Ghost Guns
- Convene Events to Improve Criminal Justice and Community Safety
 - Statewide Fentanyl Summit
 - Financial Crimes Investigation Training
 - School District SRO Summit
 - Chair of Adams/Broomfield Criminal Justice Coordinating Council
